

RESOLUTION ME-2022-2

**A RESOLUTION BY THE BOARD OF DIRECTORS
OF THE
WESTERN KANSAS GROUNDWATER MANAGEMENT DISTRICT NO. 1
TO ADOPT THE FY 2023 BUDGET AND
SET A LAND ASSESSMENT AND WATER USER CHARGE**

WHEREAS, the Western Kansas Groundwater Management District No. 1 (hereinafter the "District") was established under the authority of K.S.A. 82a-1020 for the proper management of groundwater resources of the state; and

WHEREAS, the District is a body politic and corporate and has the authority to levy a water user charge and land assessment under K.S.A. 82a-1028 (h) to finance the operations of the District; and

WHEREAS, the Board of Directors (hereinafter the "Board") has adopted a proposed budget at this year's annual meeting; and

WHEREAS, the Board has submitted the proposed budget for FY 2023 to the eligible voters of the District at a budget hearing called for that purpose; and

WHEREAS, at least one (1) budget hearing notice was published in a newspaper or newspapers of general circulation within the District at least twenty-eight (28) days prior to the budget hearing;

THEREFORE, be it now resolved that the Board of Directors of the Western Kansas Groundwater Management District No. 1 hereby adopts the proposed FY 2023 budget as submitted at the budget hearing with assessment revenue totaling \$432,000 and expenditures totaling \$591,500.

The land assessment is hereby set at five (\$0.05) cents per acre for eligible tracts of land as defined by K.S.A. 82a-1030 (a).

The water users charge is hereby set at sixty cents (\$0.60) for each acre-foot of groundwater as defined by K.S.A. 82a-1030 (a).
